## **IRS Practice and Procedure**

LOAN VERSUS INCOME – *Novoselsky v. C.I.R.*, T.C. Memo 2020-68 (2020)

Why This Case is Important: Sometimes it is unclear whether a payment constitutes a loan to the recipient, which is not subject to income tax, or income, which is taxed. This case is an example of when a payment that looks like a loan is actually taxable income.

Facts: The taxpayer in Novoselsky was a Chicagobased class action attorney. From 2009 through 2011, he was trying to put together certain class action lawsuits with doctors as plaintiffs. Because he did not have the money to fund these lawsuits, he convinced some doctors to give him the funds he needed. With each of these individuals, he signed a "Letter Agreement for Litigation Support," which characterized the money he received as a loan that would be repaid at the successful conclusion of the lawsuit. Some attorneys also agreed to help fund these lawsuits, and again the taxpayer signed "loan" documents agreeing to repay them from attorney fees awarded by the court, if any. The taxpayer raised approximately \$400,000 in 2009 and \$1 million in 2011. Because he considered the funds to be loans, he did not report them as income or pay taxes on them. The IRS audited his 2009 and 2011 income tax returns and determined that the funds should have been reported as income. It issued him notices of deficiency assessing a total tax liability of almost \$540,000 and penalties in excess of \$100,000. The taxpayer filed a Tax Court petition contesting these assessments.

Law and Conclusion: Section 61(a) of the Internal Revenue Code broadly defines gross income to include "all income from whatever source derived." Under this rule, most receipts of cash constitute gross income and are taxable. However, because loans must be repaid, loan proceeds do not constitute income and are not taxed. The issue in this case is whether the

funds received by the taxpayer were loans for income tax purposes. Courts have held that, to be considered a loan, the obligation to repay "must be unconditional and not contingent on some future event." If the obligation to repay only arises on the occurrence of a future event, a valid debt does not exist for federal income tax purposes. In this case, the payments to the taxpayer only had to be repaid if his class action lawsuits were successful. Because the taxpayer's obligations to repay were contingent on future events, the Court held that the payments to the taxpayer were not loans. Instead, the Court characterized them as advance payments for services to be provided by the taxpayer. That being the case, the payments were taxable income to the taxpayer and the Court found in favor of the IRS.

USE OF PRIVATE DELIVERY SERVICES IN IRS FILINGS - *Organic Cannabis Foundation*, *LLC* v. C.I.R., No. 17-72874 (9th Cir. 2020)

Why This Case is Important: With so many IRS filings having to be filed by a specific deadline to be considered valid, it is important to observe these deadlines and carefully follow IRS filing procedures. This case is an example of the harsh consequences of not doing so.

Facts: In this case, the taxpayer, through its attorney, was attempting to file Tax Court petitions to contest notices of deficiency issued by the IRS assessing taxes and penalties in excess of \$1.3 million. The deadline to file the petitions was April 22, 2015. The taxpayer's attorney readied the petitions for filing on April 21, 2015 and instructed his assistant to have them delivered to the IRS using its overnight delivery service. The assistant used the FedEx "First Overnight" service, the quickest service offered by FedEx, and the petitions were scheduled to be delivered at 8:30 A.M.

on April 22. However, when the FedEx driver attempted to deliver the petitions, he could not reach the delivery point for some reason and the delivery was rescheduled for the following day. It was ultimately delivered on April 23. The IRS responded to the petitions by filing a motion to dismiss, arguing that the Tax Court did not have jurisdiction over the petitions based on them not having been filed by the filing deadline. The Court agreed and dismissed the case. The taxpayer appealed this dismissal to the Ninth Circuit Court of Appeals.

Law and Conclusion: To protect taxpayers who mail a document on time only to have that document delivered after a filing deadline, Section 7502(a)(1) of the Internal Revenue Code provides that if a document is received by the IRS, it will be deemed to have been delivered on the document's postmark date (the "mailbox rule"). However, for the mailbox rule to

apply, the document must be sent using a service that appears on the IRS's of approved delivery services. This list includes registered mail, certified mail, and certain other private delivery services. As of 2015, the list of approved private delivery services had not been updated since 2004. While the list did include certain FedEx services, because the "First Overnight" service did not exist in 2004, it was not included on the list of approved services. That being the case, under a strict reading of Section 7502, the taxpayer did not mail its petitions using an IRS-approved service and the mailbox rule did not apply. Accordingly, the date of delivery of the petitions was the date they were actually received by the IRS – April 23, 2015, one day after the petitions' filing deadline. Based on the filing deadline not having been met, the Appeals Court found in favor of the IRS and upheld the Tax Court's dismissal.

## **MCLE Compliance Deadline Extension**

## ATTORNEYS WITH JUNE 30, 2020 AS THEIR MCLE COMPLIANCE DEADLINE MAY CHOOSE A THREE-MONTH EXTENSION AT NO COST

The Illinois Supreme Court recognizes that, due to the COVID-19 pandemic, attorneys with last names beginning A-M in the 2018-2020 reporting period may be unable to complete their continuing education credits by the upcoming June 30, 2020 deadline. In consultation with the MCLE Board, the Court has decided to provide every attorney in this group the option to secure a no-cost, three-month extension to complete those credits. An attorney secures that extension by submitting an online report to the Board no later than July 31, 2020.

The Board's online reporting system at www. mcleboard.org is available now for attorneys in the 2018-2020 reporting period. Attorneys who complete their credits by June 30, 2020 will report compliance at any time by July 31, 2020 at no cost.

For attorneys who do not complete their credits by June 30, 2020, they will report "Not Yet Complied" to the Board online at www.mcleboard.org by July 31, 2020 to secure the three-month extension at no cost.

No reason for the extension is needed. Those attorneys then have until September 30, 2020 to complete their credits and report compliance to the Board.

Announcing these changes, Chief Justice Anne M. Burke said, "with more than 42,000 active status attorneys in this reporting group, the Court is mindful of the range of challenges in attorneys' professional and personal lives caused by this pandemic. Allowing attorneys to claim a three-month extension at no cost permits those facing the June 30, 2020 compliance deadline the option to secure additional time to complete their continuing legal education requirements."

Illinois attorneys may earn all of their MCLE credits through accredited distance learning options, such as live video or audio courses or recorded sessions. With more than 21,000 Illinois-accredited distance learning options available, an attorney can set the time, place, and pace of their learning without travel or exposure to large groups. You can search for courses using the Board's online course search page, setting parameters such as your preferred date and location.

Further, hundreds of free accredited courses are available. Three Court entities offer free online courses: the Attorney Registration & Disciplinary

Commission, the Commission on Professionalism, and the Lawyers' Assistance Program. Many of their courses provide professional responsibility credits, including mental health/substance abuse and diversity/inclusion sessions. To search for other free courses, access the Board's online course search page, then enter 0 in the "Cost No More Than" field along with any other parameters.

Any attorney encountering difficulties in completing their MCLE credits by either the June 30, 2020 or September 30, 2020 deadline is encouraged to contact the MCLE Board at 312-924- 2420.

"The Board staff is highly skilled at working with individual attorneys who are facing health, financial, or other challenges. We offer this service in every reporting period, but we recognize that the need is even greater now," said Michele M. Jochner, MCLE Board chair, a partner at Schiller, DuCanto & Fleck LLP.

Here are the details for an attorney to choose between the June 30, 2020 deadline and the September 30, 2020 deadline:

## • Option 1: Keeping June 30, 2020 compliance deadline

For an attorney who completes the required credits or has a valid out-of-state exemption by June 30, 2020, that attorney reports "Complied" or the exemption on the Board's website, by July 31, 2020. No other report is needed, and no fee is due.

## • Option 2: Selecting the September 30, 2020 deadline

To choose this option, the attorney reports "Not Yet Complied" on the Board's website, no later than July 31, 2020. With that report, the attorney obtains a new deadline of September 30, 2020, to complete the required credits and report compliance online to the Board. No fee is due this year for securing this new deadline.

**Please note:** If an attorney fails to submit a report choosing Option 1 or Option 2 no later than July 31, 2020, the attorney will incur a \$250 late fee and need to complete their credits and report compliance to the Board no later than September.

## **Beyond the Courtroom: Community Outreach**

The most significant event of my life is my mother dying from cancer when I was in sixth grade. It was the hardest thing I have ever gone through and to say it did not affect me in the most significant ways would be perjury. As hard as that was, the worst moment of my life is when I realized I could not remember her voice.

After she died, anytime I would miss her or feel alone I would listen to her voice in my head. I could hear the love, kindness and compassion as I let the memory of her voice wash over me. It comforted me and made me feel like I was not alone. My single father had a business to run, my brother who needed special attention and my sister who he was trying to raise without a female influence. With all that going on, it meant that I was the odd one out and left to do many things myself. When I went to jr. high school to register for 8th grade I was alone. I do not mean I felt alone, I mean my dad dropped me off at the school and said I have to deal with your sister and brother so have fun and get out. I remember seeing all of the other kids with one or both parents and I felt like I was alone in this world. So I did what I always did, I listened to my mom's voice in my head and I felt like she was with me.

My mom's voice stayed with me for most of high school and then one long hard day I tried to listen for my mom's voice only to discover I had lost it. I watched a video of her twice and at the end I still could not hear her voice in my head. I knew what she sounded like from the video but I could not remember it for myself. At that moment I had lost my mom for the second time. The first time I lost her I had people alongside me mourning the loss with me. The second time, however, I was all alone. When I lost the memory of her voice, for the first time I felt truly alone.

When I was in law school clerking for the Public Defender's office I saw how scared the client's were when they were alone. Since they could not afford a lawyer, many people thought that they had to deal with the charges themselves (which as we

know is a bad idea). When the judge assigned them a lawyer it was like a heavy burden was lifted off their shoulders because they were not alone. The biggest problem, however, was that when the client left court, they were again alone. There were many clients who were homeless or starving on the street and there was nothing the lawyers could do about it.

After seeing that, I could not ignore the reality of life, some people are really alone and have no one. When they need money for food or rent they can't call their brother or sister they just go hungry or become homeless. After that jolt of reality, I decided that I was not going to just be a spectator when I saw someone suffering. I was not going to let anyone be alone and suffering if I could help it. I started by volunteering at an immigration clinic, then one day I walked into Northwest Compass and my life changed. Northwest Compass is a non-for-profit that assists people with anything from getting food for their family to getting housing and homeless assistance. It was the first time I found a place that I could really help people in meaningful ways.

It has been many years (and a lot less hair) since I walked in Northwest Compass and I am now the chair of the board of directors. It took me many years to figure out I was not alone and many more years to figure out how to make sure no one else feels that way. Everyday I make sure my clients, friends, family and anyone I meet know they are not alone. I want them and everyone to know, there are people who care about you and you do not have to do this alone. If we are all together then no one is alone.

## Are You Leaving Money on the Table?

Most small businesses, 500 employees or less are familiar with the Coronavirus Aid, Relief, and Economic Security, "CARES" Act, P.L. 116-136, which included the Paycheck Protection Program, better known as the "PPP" loans. Almost all small businesses, and some not so small, were lathering at the mouth to get funded with these advantageous loans, PPP, that provide the potential for 100% forgiveness without incurring taxable income.

So, you already have a loan and do not believe you left money on the table from the CARES Act?

You might have!

Did you look at the less well known, but it will become far more well known, Families First Coronavirus Response Act, "FFCRA"? Let's look at less know provisions, including a CARES Act provision and see how you can get more money in your business pocket and off of the table!

There are three credits that have not been receiving a lot of publicity:

- 1. Employee Retention Credit
- 2. Emergency Paid Sick Leave Act
- 3. Medical Leave Expansion Act

The Employee Retention Credit is found within the Cares Act, Sec. 2301. This specific Credit allows an employer to receive a payroll tax credit for fifty percent, (50%), of wages paid to employees, with a maximum per employee of \$10,000, when a business had to fully or partially close due to governmental orders due to COVID-19.(Remember State orders are "governmental" orders) Another way to qualify for this payroll tax credit is from a decline in gross revenues, compared to the prior year. This particular credit is based on a quarterly analysis and is further subdivided between the number of employees that a business had, either greater or less than 100 full time employees.

Businesses with 100 or less full-time employees in 2019, compute the credit calculation based upon the total of all qualified wages, which includes qualified health care expenses, paid to all employees during the quarter or quarters at issue. This amount is compared to the applicable period in 2020.

Note: there is no double or triple dipping. If an employer claims a credit under either of the above 2 remaining credits, namely the Emergency Paid Sick Leave Act or the Medical Leave Expansion Act, then an employer cannot also claim a tax credit for the retention credit. One more note of caution, if such business received a Small Business Interruption Loan they also are excluded from utilizing the Employee Retention Credit.

Let us move from the CARE'S act to the FF-CRA credits. According to the IRS, Instructions for Form 7200, the following two credits may be claimed for wages paid on qualifying leave wages paid for the period between April 1, 2020, and December 31, 2020.

The Emergency Paid Sick Leave Act is found within the FFCRA Sec. 5102. The section at first glance may appear onerous as it "requires" employers to provide up to 80 hours of compensated sick leave per full time employee, and the employee is subject to a Federal, State, or local quarantine or isolation order related to COVID–19 or its effects, are unable to work. There is a specific list of guidelines:

- a. The employee is subject to quarantine or self-isolation
- b. Is caring for an individual who is subject to quarantine or self-isolation.

c. An individual is experiencing substantially similar circumstance specified by the Secretary of Health and Human Services and is seeking a medical diagnosis

This specific paid sick leave is in addition to the Company policy on paid sick leave and not only may be used prior to other sick leave, but also includes part time employees! A credit is available, with limitations, from the federal government to fund this requirement in full, for each dollar paid. Also, the pay limitations are reduced if the sick leave pay is at a reduced level or if the absence is due to caring for another who is ill, rather than the employee's own sickness or isolation.

The Medical Leave Expansion Act is the third tool in the toolbox for additional tax relief for small employers. It applies if an employee is unable to work due to a public health emergency, due to Covid, and:

- a. A child's school being closed due to the coronavirus or
- b. The child's daycare is closed due to the coronavirus

If the Employee needs leave to take care of such child or children, then this section provides for up to ten weeks paid leave with a credit available for such payments to the employee or 66.23% of regular pay.

The design of these benefits is for the federal government to provide payroll tax credits to make a business whole, within payment limitations, through a payroll tax credit taken upon a businesses' payroll tax forms, generally Form 941 or equivalent. (Form 941 PR for Puerto Rico). The amount of withheld taxes, FICA and Medicare may be retained by the business to equal the credit. However, many businesses may have to wait for a very long time to pay in a sufficient amount of payroll taxes to obtain such credit.

The government has provided a methodology to receive the payroll tax credit in advance by filing a Form to claim advance payroll tax refunds, Form 7200. Note self-employed persons are also entitled to such credit but do not use Form 7200 to claim it. It is not only the Wages or Paid Leave, that are reimbursable to the business, it is also the amount of qualified health care costs and the Employer's share of Medicare tax as well.

#### What about FICA?

Ok, you think I missed the FICA tax right? Actually not, remember that only wages or remuneration for employment is covered by IRC Sec. 3121(a). As the above enumerated payments are NOT wages for FICA purposes, no FICA tax is due! So, if you are not using all the above credits and any sick leave, employee leave or a reduction in business occurred, you may be leaving money on the table!
